Home Modification & Remodels

HomeFitters Program

Provides accessibility home modification services through **PROJECT: *Home Sweet Home***. This is a multi-family project where we select families to provide no cost modifications. The goal is to remove barriers to accessibility throughout the home for people of all ages living with physical disabilities. Through **PROJECT: *Home Sweet Home***, our *HomeFitters* program ensures a healthy and safe home while creating an environment that encourages, empowers, energizes and engages.
